1. **FY 18/19 Budget Update**

The proposed FY 18 /19 Budget is now available for review. As you will see, the Village is facing some challenges that will require a combination of new revenue and reductions in spending. Our goal is to maintain current service levels while also evaluating ways to provide financially sustainable solutions to meet our long-term obligations.

The staff looks forward to reviewing the proposed department budgets with you starting at the regular meeting on Tuesday, March 6. Prior to the meeting, Nikki and I will be available to answer questions on any part of the proposed budget.

1. **Proposed Overnight Parking Permit Policy**

Below is a draft of the proposed Overnight Parking Permit Policy. The Department is recommending the implementation of the Policy for one (1) year. In the spring of 2019, the Department will provide a detailed report to the Board evaluating the effectiveness of the Policy. The report will include information on the number of permits issued, problems, complaints and successes and a recommendation as to whether the Village should extend the Policy.

Below is the proposed Policy for your consideration:

Period: Available throughout the year (restrictions apply)

Parameters: Residents can request an Overnight Parking Permit that will allow parking of two (2), **non-commercial vehicles** overnight on a residential street during an extended period of time. A maximum of two (2) permits may be issued per residence.

Eligibility for Overnight Parking Permit:

Residents must currently be utilizing their garage's full design capacity to park household, non-commercial vehicles. This excludes boats, snowmobiles, motorcycles etc. Example: In a two (2) car garage, both stalls within the garage must be open to allow parking of household, non-commercial vehicles. The stalls **must remain open and available** for parking for the duration of the Overnight Parking Permit.

Permit Application – Online and In-Person

- Permit applications will be available Online, at the Police Department or Village Hall.
- VHPD Records will administer the program via the Frontline system.
- Laminated permits including applicable dates will be issued and shall be displayed on the vehicle's front dash to inform neighbors of the permits existence and parking authorization.
- Applicants must come to the Police Department to pay fees and pick up laminated permits.

Application Information

- Proof of current vehicle registration (vehicles must be registered to the property)
- Provide vehicle information including: Make, Model, Color, Year, Lic. Plate #
- Copy of the Driver's License of the principle driver.
- Contact information including phone numbers and email addresses.

*Application is subject to current On-Street Permit verification process.

Owner Responsibilities:

- Obey all posted signs regulating parking on the street adjacent to the residence.
- Park on the correct side of the street.
- Maintain vehicle in an operable state at all times.
- Vehicles may not remain parked in the same spot for more than 24 hours at a time.
- Display laminated permit on vehicle dash.
- Adhere to snowfall parking restrictions.

Available Time Periods for Permits: 30, 60 or 100 days

- Permits may be issued consecutively, but shall not exceed 130 days in a row or more than 190 days per year. There will be a minimum 30 day waiting period between the issuance of a new permit once the 130 consecutive day threshold has been met.

Permit Costs: \$50 for 30 days; \$75 for 60 days; \$100 for 100 days

- Should a resident need to extend a current permit to a longer time duration, only the difference in cost between the two passes shall be paid. Example: A fifty (\$50) dollar, 30 day permit extended to a 60 day permit will only be subject to an additional \$25 fee.

Recommendation:

Should the Village Board agree with the suggested policy or provide modified policy direction, it is recommended that staff be directed to prepare the necessary ordinance authorizing the implementation the Policy and associated fees for one (1) year. We would further recommend that the Policy expire on March 30, 2019 unless otherwise extended or terminated by the Board.

On February 6, the Committee of the Whole unanimously directed staff to prepare the necessary ordinance approving an amendment to a Special Use for a Planned Unit Development for Port Clinton Place to allow the construction of an 18-unit townhome development en lieu of the previously approved 80-unit multi-family building.

Taxman Corporation was receptive to comments received at the Committee of the Whole from concerned residents and made modifications to the landscape plan. The landscape plan was amended to move two proposed Colorado Green Spruces from north of Building 11 to the triangular area adjacent to the fire access. The landscape plan includes the requested Dwarf Birds Next Spruce in this same area. Sidewalks were also included on the plan that allows access to the front of the buildings from the guest parking spaces. Village staff believes the screening and sidewalk concerns have been addressed and is supportive of the proposed landscape plan.

Ordinance 2018-021 is recommended for approval.

I. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018 – 022 - ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE YEAR 2017 TO PAY THE PRINCIPAL OF AND INTEREST ON \$3,790,000 GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2005, OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS

The Village has issued General Obligation Bonds in the past to fund a variety of projects, including several in the VHTC TIF District. These bonds are supported by the “full faith and credit” of the Village, meaning that upon the formal approval and passage of the ordinance for the bonds, an automatic property tax levy is created to in annual amounts sufficient to make principal and interest payments. Each year, the Board passes an ordinance to abate (eliminate) this levy each year via an abatement ordinance, because these payments are paid from General Fund Revenues. The 2005 General Obligation Bonds were specifically issued to refinance bonds issued in 2001 for the Vernon Hills Athletic Complex.

This ordinance must be passed and filed with the Lake County Clerk's office prior to the end of February to eliminate the statutorily authorized levy. A separate ordinance is required for each of the outstanding bond issues.

Ordinance 2018-022 is recommended for approval in order to zero out the property tax levy that would otherwise be released for the Series 2005 debt issue for the 2017 levy (2018 collection year).

J. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018 – 023 - ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE YEAR 2017 TO PAY THE PRINCIPAL OF AND INTEREST ON \$7,850,000 GENERAL OBLIGATION BONDS, SERIES 2012A, OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS

Each year, the Board passes an ordinance to abate (eliminate) this levy via an abatement ordinance, because debt payments for this issue are paid from General Fund Revenues. The 2012B General Obligation Bonds were specifically issued to refinance the bonds issued in 2006 for the purchase of the Police Communications Center.

This ordinance must be passed and filed with the Lake County Clerk's office prior to the end of February to eliminate the statutorily authorized levy. A separate ordinance is required for each of the outstanding bond issues.

Ordinance 2018-024 is recommended for approval in order to zero out the property tax levy that would otherwise be released for the Series 2012B debt issue for the 2017 levy (2018 collection year).

The Village's outstanding General Obligation Bonds include an automatic property tax levy that is created upon the formal approval and passage of the ordinance. The levy is created in annual amounts sufficient to make payments for principal and interest payments. Each year, the Board passes an ordinance to abate (eliminate) this levy via an abatement ordinance, because debt payments for this issue are paid from General

Fund and TIF Revenues. The 2014 General Obligation Bonds were specifically issued to refinance a portion of the bonds issued in 2007 for the Vernon Hills Town Center TIF District, and for the remodel of the Police Station.

This ordinance must be passed and filed with the Lake County Clerk's office prior to the end of February to eliminate the statutorily authorized levy. A separate ordinance is required for each of the outstanding bond issues.

Ordinance 2018-025 is recommended for approval in order to zero out the property tax levy that would otherwise be released for the Series 2014 debt issue for the 2017 levy (2018 collection year).

M. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018 – 026 - ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE YEAR 2017 TO PAY THE PRINCIPAL OF AND INTEREST ON \$2,005,000 GENERAL OBLIGATION BONDS, SERIES 2015A, OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS

The Village's outstanding General Obligation Bonds include an automatic property tax levy that is created upon the formal approval and passage of the ordinance. The levy is created in annual amounts sufficient to make payments for principal and interest payments. Each year, the Board passes an ordinance to abate (eliminate) this levy via an abatement ordinance, because debt payments for this issue are paid from General Fund Revenues. The 2015A General Obligation Bonds were specifically issued to contribute towards the Park District's acquisition of the Opa Property and the purchase of the Starcom Radio Network and equipment for the Police Department.

This ordinance must be passed and filed with the Lake County Clerk's office prior to the end of February to eliminate the statutorily authorized levy. A separate ordinance is required for each of the outstanding bond issues.

Ordinance 2018-026 is recommended for approval in order to zero out the property tax levy that would otherwise be released for the Series 2015A debt issue for the 2017 levy (2018 collection year).

The Village's outstanding General Obligation Bonds include an automatic property tax levy that is created upon the formal approval and passage of the ordinance. The levy is created in annual amounts sufficient to make payments for principal and interest payments. Each year, the Board passes an ordinance to abate (eliminate) this levy via an abatement ordinance, because debt payments for this issue are paid from General Fund Revenues. The 2015B General Obligation Bonds were specifically issued to refinance the last remaining portion of the 2007 Vernon Hill Town Center TIF District Bonds.

This ordinance must be passed and filed with the Lake County Clerk's office prior to the end of February to eliminate the statutorily authorized levy. A separate ordinance is required for each of the outstanding bond issues.

Ordinance 2018-027 is recommended for approval in order to zero out the property tax levy that would otherwise be released for the Series 2015B debt issue for the 2017 levy (2018 collection year).

O. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018-028 - AN ORDINANCE AMENDING ORDINANCE 2016-045 AND ORDINANCE 2017-124 GRANTING CERTAIN APPROVALS FOR PROPERTY COMMONLY KNOWN AS MELODY FARM LOCATED AT THE INTERSECTION OF MILWAUKEE AVENUE AND TOWNLINE ROAD, IN THE VILLAGE OF VERNON HILLS, LAKE COUNTY

Ordinance 2018-028 was unanimously recommended for approval at the Committee of the Whole meeting on February 6. The Ordinance amends Ordinance 2016-045 and Ordinance 2017-124 to remove the requirement of Regency Centers to install roadway lighting at the Route 60/21 intersection and associated transitional lighting on the following conditions:

1. Regency Centers provides the Village a one-time payment of \$200,000 in-lieu of the roadway and transitional lighting condition stated in Ordinance 2016-045 prior to issuance of the first retail certificate of occupancy.

Ordinance 2018-028 is recommended for approval.

APPROVAL AND PASSAGE OF ORDINANCE NO. 2018-029 - AN ORDINANCE AWARDED THE 2018 SPECIALIZED LANDSCAPE MOWING AND MAINTENANCE BID AND MULTI-YEAR CONTRACT TO TWIN OAKS LANDSCAPING FOR AN AMOUNT OF \$55,429; WITH AN ADDITIONAL CONTINGENCY AMOUNT OF \$15,000; FOR A TOTAL AMOUNT NOT TO EXCEED \$70,429

The Village is responsible for maintaining all Village-owned properties and rights of way (ROWs), including lawn care and maintenance. In an effort to do so efficiently and effectively, the Village contracts specialized landscape mowing and maintenance services for six locations throughout the Village as listed below:

Village Hall	Arboretum	Metra Station
Police Dept.	Public Works	Butterfield Rd. Medians

On February 7, 2018, the Village received a total of three bids for specialized landscape mowing and maintenance services with Twin Oaks Landscaping providing the lowest qualifying bid for a base price of \$55,429.

Balanced Environments - \$70,721
Milieu Design - \$56,870
Twin Oaks Landscaping - \$55,429

Beyond the base price, some contingency funds are needed for varying weather conditions such as late fall leaf clean-up, early spring work, pond work, and re-seeding efforts. A contingency of \$15,000 is included within FY2018-19 budget should such conditions occur. Additionally, staff has added mowing and maintenance of the Arboretum to this year's contract which had previously been its own separate contract; therefore, the 2018 base pricing amounts reflect the increase in the scope of work.

Staff is recommending that the Village Board award the 2018 Specialized Landscape Mowing and Maintenance Bid to Twin Oaks Landscaping for an amount not to exceed \$70,429.

Ordinance 2018-029 is recommended for approval.

Q. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018-030 - AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE VILLAGE OF VERNON HILLS, CHAPTER 5, ARTICLE IV, PROHIBITING THE USE OF COAL TAR

Research into the environmental impact of coal tar derived pavement sealants found that driveway and parking lot sealants are wide spread pollutants of water causing health threats. Polycyclic aromatic hydrocarbons (PAHs), which are contained in coal tar sealants, can be carried by stormwater and other run off into ponds, streams and wet lands.

The Village Board reviewed this topic at its Committee of the Whole (COW) meeting on September 7, 2017. At that meeting, it was determined that regulating the amount of contaminants, including Polycyclic Aromatic Hydrocarbons (PAHs) contained in coal tar sealcoat products, will improve and protect the water quality of the Village and neighboring downstream communities. Prohibiting the use of coal tar seal coating products is therefore appropriate. Staff was directed to prepare an Ordinance prohibiting such use.

As discussed at the September 7 COW meeting, the Village will reach out to businesses, shopping centers, retailers, large office/warehouse uses, property owners and associations to advise of the new regulations. We will also get the word out by using the Village web site and other forms of social media such as Facebook and Twitter.

Ordinance 2018-030 is recommended for approval.

R. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018-031 - AN ORDINANCE REPEALING ORDINANCE 2017-121 AMENDING CHAPTER 17 – POLICE; ARTICLE II – POLICE DEPARTMENT; SECTION 17-34 – OFFICES AND RANKS

In Ordinance 2017-121, the Code was amended to temporarily increase the number of Sergeants and decrease the number of Commanders. The proposed Ordinance repeals this change and reverts back to the original approved number of Sergeants (4) and Commanders (5).

Ordinance 2018-031 is recommended for approval.

S. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018 -032 - ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE YEAR 2017 TO PAY THE PRINCIPAL OF AND INTEREST ON \$20,190,000 TAXABLE GENERAL OBLIGATION BONDS, SERIES 2017, OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS

The Village's outstanding General Obligation Bonds include an automatic property tax levy that is created upon the formal approval and passage of the ordinance. The levy is created in annual amounts sufficient to make payments for principal and interest payments. Each year, the Board passes an ordinance to abate (eliminate) this levy via an abatement ordinance, because debt payments for this issue will be paid from remaining bond proceeds for the next three years, while the Melody TIF District is under construction. Once this three-year period passes, it is anticipated that the TIF increment received on the property will be sufficient to make debt payments. The 2017 Taxable General Obligation Bonds were specifically issued to provide financial assistance for the Melody Farm TIF District Developments.

This ordinance must be passed and filed with the Lake County Clerk's office prior to the end of February to eliminate the statutorily authorized levy. A separate ordinance is required for each of the outstanding bond issues.

Ordinance 2018-032 is recommended for approval in order to zero out the property tax levy that would otherwise be released for the Series 2017 debt issue for the 2017 levy (2018 collection year).

T. APPROVAL AND PASSAGE OF ORDINANCE NO. 2018-033 - AN ORDINANCE AN ORDINANCE AUTHORIZING THE PURCHASE OF A CABLE STUDIO PLAYBACK SYSTEM FROM VSA CHICAGO IN AN AMOUNT NOT TO EXCEED \$17,459

On March 7, 2017, Mike Storto, the Village's Cable Coordinator, presented a plan to upgrade the Village Board Room Video Recording System and Playback System. Based on the consensus of the Committee of the Whole, and in accordance with best practices in purchasing, staff issued a Request for Proposals (RFP) for the Board Room upgrade. Based on the price quotes received as part of the RFP, staff recommended delaying the replacement of the Playback System until a later date.

In mid-December, the existing Playback System failed, eliminating the ability to schedule programming and the use of the bulletin board feature on Channel 4. Updated quotes were sought to replace the system from three (3) vendors. The vendors responded as follows:

The Cable Studio Budget includes sufficient funds in the current year to replace the playback system.

VSA Chicago is based out of Buffalo Grove, Illinois and has been in operation since 1976. They have specifically completed projects in this area for Vernon Hills High School, the City of Aurora, City of Joliet and Village of Romeoville. They are a nationwide reseller of professional video and audio equipment.

Ordinance 2018-033 is recommended for approval to approve the agreement with VSA Chicago to replace the Cable Studio's Playback System.

WHEREAS, Ordinance 2006-51 approved a Special Use Permit for Port Clinton Place, a Planned Unit Development consisting of 47 townhomes and 132 condominiums located on Route 45, West of Milwaukee Avenue to Opus Development Company.

WHEREAS, Ordinance 2006-57 amended Ordinance 2006-51 to amend the final architectural plans for the Port Clinton Place PUD.

WHEREAS, Ordinance 2017-015 amended both Ordinance 2006-57 and Ordinance 2006-51 to amend the final site and architectural plans for the Port Clinton Place PUD to allow the construction of an 80 unit multifamily building.

WHEREAS, Margie Georgopulos, representing The Taxman Corporation in regards to property commonly known as Port Clinton Place PUD, has petitioned the Village of Vernon Hills for the following:

WHEREAS, representatives of Regency Centers, in regard to property commonly known as Melody Farm, have petitioned the Village of Vernon Hills to amend the Melody Farm PUD previously granted pursuant to Ordinance 2016-045 and 2017-124 to remove the requirement of Regency Centers to install roadway lighting at the Route 60/21 intersection and associated transitional lighting; and

WHEREAS, Exhibit E of the Ordinance 2016-045 contained outstanding Technical Review comments that Regency Centers and Focus agreed to address as part of the permit approval process; and

WHEREAS, Exhibit E required the lighting of Route 60/21 intersection and IDOT required transitional lighting; and

WHEREAS, It has been determined that it is not feasible to complete the intersection lighting and transitional lighting and in lieu thereof, Regency Centers has offered to provide the Village \$200,000 for the construction of public improvements along Milwaukee Avenue between Uncle Julio's and Ring Drive; and

WHEREAS, the Board of Trustees, having reviewed and considered the revisions at their Committee of the Whole meeting on February 6, 2018, found that the amendment sufficiently complies with the requirements of Ordinance 2016-045 authorizing a Special Use Permit for a PUD and which, in its judgment, would justify granting approval of the revisions.

ORDINANCE NO. 2018-030

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES
OF THE VILLAGE OF VERNON HILLS, CHAPTER 5,
ARTICLE IV, PROHIBITING THE USE OF COAL TAR**

WHEREAS, the President and Board of Trustees of the Village of Vernon Hills is authorized to prescribe minimum standards for the purpose of promoting the public health, safety, convenience and general welfare for the people of Vernon Hills; and

WHEREAS, numerous natural assets exist within the Village, including ponds, streams and wet lands which enhance the Village’s environmental, recreational and cultural resources, and contribute to the health and welfare of the community; and

WHEREAS, recent research into the environmental impact of coal tar derived pavement sealants with the objective of improving storm water management and to address water pollution, found that: (i) driveway sealants are wide spread pollutants of water and major health threats; (ii) homeowners and businesses can easily use similar sealant products without coal tar; and (iii) many municipalities and states have banned the use of coal tar; and

WHEREAS, the President and Board of Trustees having reviewed this matter at its Committee of the Whole meeting on September 7, 2017; determined that prohibiting the use of coal tar sealants on public and private property within the Village and to prohibit the sale of coal tar sealants by businesses located within the Village is necessary to promote the health and welfare of the community.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. That Chapter 5, Article IV, Section 5-80, “Pavement Sealants” of the Vernon Hills Code of Ordinances is hereby created and approved to read as follows:

Section 5-80 Pavement Sealants

(a) Introduction/Purpose.

It is the intent and purpose of this Section to provide regulations that protect the natural assets within the Village, including ponds, streams and wet lands, and which enhance the Village’s environmental, recreational and cultural resources, and contribute to the health and welfare of the community.

(b) Applicability

This Ordinance shall apply to the use of coal tar sealants on public and private property within the Village, and to the sale of coal tar sealants by businesses located within the Village.

(c) Definitions.

1. **Coal Tar Products:** means pavement sealant or sealcoat products that contain coal tar, coal tar pitch, coal tar derivatives, coal tar pitch volatiles, coal tar mixtures or any variation assigned the Chemical Abstracts Service (CAS) numbers 65996-93-2, 65996-89-6, or 8007-45-2.
2. **Pavement Sealing:** means the application of sealant or sealcoat products to maintain any surface, including but not limited to: a street, driveway, driveway approach, drive aisle, on

or off-street parking area, sidewalk, bike trail, patio, sports facility, loading area or facility, roadway or similar paved surface.

3. Person: means any individual, partnership, firm or corporation.

(d) Sale of Coal Tar Products Prohibited

No person shall sell, offer or display for sale within the Village, at wholesale or at retail, Coal Tar Products of any kind.

(e) Use of Coal Tar Products Prohibited

On public or private property, no Coal Tar Products of any kind shall be applied or used on the surface of any street, driveway, driveway approach, drive aisle, on or off-street parking area, sidewalk, bike trail, patio, sports facility, loading area or facility, roadway or similar paved surface within the Village.

(f) Penalty

Any person found violating any terms of this Chapter shall be found guilty of a misdemeanor and shall, upon conviction thereof, be fined in an amount not less than that described in the Village Code of Ordinances, Chapter twenty five (25), Comprehensive Fees and Penalties.

In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. SECTION III. EFFECTIVE DATE. This ordinance shall be in full force and effect forthwith upon its passage by the Corporate Authorities and signing and approval by the President.

SECTION IV. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION V. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION VI. PUBLICATION. This ordinance shall be published in pamphlet form in the manner provided by law.

SECTION VII. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION VIII. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2018-032.
