OPENING / INTRODUCTORY COMMENTS - VM FLEISCHHAUER

Village Manager Fleischhauer thanked Ed McKee and Anne Fairbairn for their hard work to be able to present a balanced budget and introduced the proposed budget.

A. BUDGET OVERVIEW

Ed McKee gave an overview of the budget and noted that they were presenting a balanced proposed budget. The proposed budget amount is \$27,155,428 representing a 2.9% overall increase.

V. GOLF COURSE

Kemper Sports Management, VP Operations Lytton and General Manager Poblocki presented the Municipal Golf Course budget. The Golf Course budget is \$439,740 representing an 11% increase from the 2019/20 approved budget.


3. ADJOURNMENT
