Jeff Fougrousse, Executive Director, Vernon Hills Park District, appeared before the Liquor & License Commission to request Class G liquor licenses for its Rib Fest, Craft Beer Tasting, and Finn’s Up events. Rib Fest would be held at Century Park on August 21 and 22. Craft Beer Tasting would be held at Sullivan Center on February 29. Finn’s Up would be held at the Family Aquatic Center on August 1. 
