

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-020**

**AN ORDINANCE AMENDING CHAPTER 22, ARTICLE III, DIVISION 1, SECTION 22-256
OF THE VERNON HILLS VILLAGE CODE FOR STREET AND HIGHWAY PARKING
RESTRICTIONS**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (Village) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village regularly reviews and updated the Municipal Code to ensure protection of the health, safety, and welfare of the public, protection of property values and neighborhood integrity, avoiding the creation of nuisances, and insuring the continued safe and sanitary use of property within the Village; and

WHEREAS, the Village has determined that it is necessary to amend Chapter 22, Article III, Division 1, Section 22-256 of the Code that addresses Street and Highway Parking Restrictions within the Village; and

WHEREAS, the President and Board of Trustees, having determined that the requested amendment is in the best interest of the Village of Vernon Hills and hereby adopts this ordinance amending the Vernon Hills Village Code pursuant to its authority to establish reasonable regulations pertaining to development regulations within the Village of Vernon Hills.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION 1. INCORPORATION The above recitals are hereby incorporated into and made part of this Ordinance.

SECTION 2. CODE AMENDMENT Chapter 22 – Traffic and Motor Vehicles, of the Village of Vernon Hills Code of Ordinances, Article III – Stopping, Standing, and Parking; Division 1 – Generally; Section 22-256 - Prohibited in specific places will have the table titled Street and Highway Parking Restrictions updated to include the following:

SECTION	TYPE	STREET	FROM	TO	SIDE
3	No Parking This Side Of Street	Cherry Valley Road	200 FT east of Westmoreland Drive	Camden Place	West

SECTION 3. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION 4. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION 5. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION 6. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2024-020.






