

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-030**

AN ORDINANCE AWARDING THE PUTTING GREEN AND SHORT GAME CONTRACT TO HOLLEMBEAK CONSTRUCTION, INC. FOR AN AMOUNT NOT TO EXCEED \$342,819

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village desires to expand the offerings at its Municipal Golf Course; and

WHEREAS, the Village received a total of two (2) sealed bids on March 6, 2024 for the Putting Green and Short Game project; at which time they were publicly opened; and

WHEREAS, Hollembeak Construction, Inc. provided the lowest qualifying bid; and

WHEREAS, this Ordinance awards the Putting Green and Short Game project to Hollembeak Construction, Inc. for an amount not to exceed \$342,819.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required contract documents for the Putting Green and Short Game project with Hollembeak Construction, Inc. for a price not to exceed \$342,819.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Hollembeak Construction, Inc. in an amount not to exceed \$342,819.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.


SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-030.






