

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-028**

**AN ORDINANCE AWARDING THE 2024 BITUMINOUS PAVEMENT
PATCHING PROGRAM CONTRACT TO CHADWICK CONTRACTING FOR
AN AMOUNT NOT TO EXCEED \$150,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned properties, and Village rights of ways (ROW's); including public streets; and

WHEREAS, to do so efficiently and effectively, the Village contracts asphalt patching of damaged sections of pavement on various public streets on an annual basis; and

WHEREAS, the Village received a total of six (6) sealed bids on February 29, 2024 for the Bituminous Pavement Patching Program; at which time they were publicly opened; and

WHEREAS, Chadwick Contracting provided the lowest qualifying bid; and

WHEREAS, \$150,000 is delineated within Fiscal Year 2025 budget account (0218151-550065) for the 2024 Bituminous Pavement Patching Program; and

WHEREAS, this Ordinance awards the 2024 Bituminous Pavement Patching contract to Chadwick Contracting for an amount not to exceed \$150,000.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required contract documents for the 2024 Bituminous Pavement Patching Program with Chadwick Contracting for a price not to exceed \$150,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Chadwick Contracting in an amount not to exceed \$150,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-028.
