ORDINANCE 2024-031

AN ORDINANCE AUTHORIZING THE PURCHASE OF RETROFIT LED STREET LIGHT FIXTURES FROM STEINER ELECTRIC FOR AN AMOUNT NOT TO EXCEED \$189,946.95

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff delineated \$200,000 in the FY2025 budget account (0218151-550056) for the purchase of LED Street Light Fixtures; and

WHEREAS, Staff sought pricing through Steiner Electric for the purchase of said fixtures and received a quote for \$189,946.95; and

WHEREAS, consolidated purchases throughout the budget year of over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is authorized to execute payments to Steiner Electric Company for the purchase of Retrofit LED Street Light Fixtures for an amount not to exceed \$189,946.95.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-031.




