

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-045**

AN ORDINANCE AMENDING ORDINANCE 2022-124 AUTHORIZING AN INCREASE OF EXPENDITURES TO ILLINOIS COUNTIES RISK MANAGEMENT TRUST (ICRMT) TO PROVIDE WORKERS COMPENSATION INSURANCE COVERAGE FROM DECEMBER 1, 2022 – DECEMBER 1, 2023 BY \$9,408

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village must maintain worker’s compensation insurance coverage (*“insurance coverage”*); and

WHEREAS, ordinance 2022-124 awarded the Village insurance contract to ICRMT for the December 1, 2022 through December 1, 2023 coverage period with premiums for this insurance coverage not to exceed \$473,763; and

WHEREAS, initial Workers Compensation insurance premiums are determined by an estimation of employee covered wages and employee classifications established by the insurance carrier; and

WHEREAS, ICRMT performs an annual audit of employee covered wages and classifications once the coverage period has concluded to determine if the initial premium paid needs to be adjusted; and

WHEREAS, the results from the ICRMT audit for the coverage period indicates additional premium due of \$9,408; and

WHEREAS, this ordinance authorizes an increase in expenditures of \$9,408 to ICRMT for additional Workers Compensation insurance premium for the coverage period identified in this ordinance which will be applied against the Village’s FY2024 Budget.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION OF PAYMENT: The Village Manager is authorized to commit the Village to make payments to Illinois Counties Risk Management Trust (ICRMT) not to exceed \$483,171 for the coverage period December 1, 2022 through December 1, 2023 and authorize the Finance Director to release these payments prior to appearing on the Board Invoice Approval List.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 5: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-045.


