

**VILLAGE OF VERNON HILLS  
ORDINANCE 2024-038**

**AN ORDINANCE AWARDING THE 2024 AQUATIC WEED AND ALGAE CONTROL SERVICES CONTRACT TO TIGRIS FOR AN AMOUNT NOT TO EXCEED \$39,455**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village currently budgets funds within budget account (0106047-520600) to provide algae control services to Village maintained pond and lake locations; and

**WHEREAS**, White Deer Run contributes \$4,800 annually towards treatment costs for ponds of concern adjacent to their property; and

**WHEREAS**, the Village received a total of five (5) proposals for the 2024 Aquatic Weed and Algae Control Services; with Tigris submitting the lowest proposal of \$39,455; and

**WHEREAS**, the term of said contract is for three years; with the option to renew up to two additional years for a total of five (5) years; and

**WHEREAS**, this Ordinance awards the 2024 Aquatic Weed and Algae Control Services contract to Tigris for an amount not to exceed \$39,455.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents for the 2024 Aquatic Weed and Algae Control services of Village ponds and lakes with Tigris for an amount not to exceed \$39,455.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to Tigris for an amount not to exceed \$39,455.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2024-038.


