ORDINANCE 2024-034**

AN ORDINANCE AMENDING ORDINANCE 2023-120 AUTHORIZING AN INCREASE OF EXPENDITURES TO GRIFFON SYSTEMS FOR THE UPDATING, CONSOLIDATING, AND EXPANSION OF A VILLAGE WIDE INTEGRATED CCTV SYSTEM BY \$3,115, TOTTALLING \$199,735

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Police Department recently remodeled the booking and detention area of the department, and

WHEREAS, the Police Department is preparing for future changes in the CCTV needs in the booking area; and

WHEREAS, Ordinance 2023-120 awarded Griffon Systems for a combined amount not to exceed \$196,620.00, and

WHEREAS, this ordinance, 2024-034, authorizes an additional \$3,115.00 increase in expenditures to Griffon Systems to provide additional requested cameras; and

WHEREAS, Staff seeks approval to increase expenditures to Griffon Systems for the Village Wide Integrated CCTV System by an additional \$3,115.00.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required contract documents for Griffon Systems for the additional \$3,115.00.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Griffon Systems, not to exceed \$199,735 in total from established and funded account 0209005-540050.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.


SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-034.




