ORDINANCE 2024-050**

**AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING  
PROCESS AND TO AUTHORIZE THE VILLAGE MANAGER TO EXECUTE A  
CONTRACT EXTENSION WITH PATRIOT PAVEMENT, INC. TO PROVIDE CRACK  
SEALING SERVICES FOR AN AMOUNT NOT TO EXCEED \$25,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining all Village-owned public streets; and

WHEREAS, to do so efficiently and effectively, the Village contracts out crack sealing services to be performed on various public streets on an annual basis; and

WHEREAS, Staff has delineated \$25,000 within FY2025 budget account (0218151-550065) for said services; and

WHEREAS, the Village participated in the 2019 Municipal Partnering Initiative (MPI) Joint Bid for Crack Sealing Services; and

WHEREAS, Patriot Pavement, Inc. was awarded a three-year contract in FY2020 to provide Crack Sealing Services through the MPI, from FY2020 through FY2022; with the option to renew said contract for two additional one-year terms through FY2024; and

WHEREAS, Patriot Pavement, Inc. has offered to extend the current contract one additional year through FY2025 for an amount not to exceed \$25,000; and

WHEREAS, Staff seeks authorization to waive the competitive bidding process and to authorize the Village Manager to execute a contract extension with Patriot Pavement, Inc. to provide Crack Sealing Services throughout FY2025 for an amount not to exceed \$25,000.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents to extend the current contract with Patriot Pavement, Inc. to provide Crack Sealing Services throughout FY2025 for an amount not to exceed \$25,000.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to Patriot Pavement, Inc. in an amount not to exceed \$25,000.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2024-050.






