

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-051**

AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND TO AUTHORIZE THE VILLAGE MANAGER TO EXECUTE A CONTRACT EXTENSION WITH TKG ENVIRONMENTAL SERVICES GROUP, LLC TO PROVIDE CONTRACTUAL STREET SWEEPING SERVICES FOR AN AMOUNT NOT TO EXCEED \$66,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff has delineated \$66,000 within FY2025 budget account (0102040-520630) for Contractual Sweeping of Village Streets; and

WHEREAS, Ordinance 2021-033 awarded a one-year contract with TKG Environmental Services Group, LLC to provide Contractual Street Sweeping Services in FY2022; with the option to renew the contract for up to two additional one-year terms through FY2024; and

WHEREAS, Staff received a favorable price of \$62,155.40 from TKG Environmental Services Group, LLC to extend the current contract for FY2025; and

WHEREAS, beyond the base price, a contingency is being included within the “not to exceed” amount for additional sweeps as needed; and

WHEREAS, Staff seeks authorization to waive the competitive bidding process, and to authorize the Village Manager to execute a contract extension with TKG Environmental Services Group, LLC to provide Contractual Street Sweeping of Village Streets throughout FY2025 for an amount not to exceed \$66,000.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to extend the current contract with TKG Environmental Services Group, LLC to provide Contractual Street Sweeping of Village Streets throughout FY2025 for an amount not to exceed \$66,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to TKG Environmental Services Group, LLC in an amount not to exceed \$66,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-051.
