

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-065**

**AN ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS PERSONAL
PROPERTY OWNED BY THE VILLAGE OF VERNON HILLS**

WHEREAS, the Village of Vernon Hills (the "Village") is a home rule municipality, having all of the powers and authority granted to such municipalities pursuant to Article VII, Section 6 of the Illinois Constitution of 1970, including the right to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Village President and Board of Trustees of the Village of Vernon Hills (the "Corporate Authorities") may dispose of personal property owned by the Village when, in the opinion of a majority of the Corporate Authorities, such property is no longer necessary, useful to, or for the best interests of the Village; and

WHEREAS, Village Manager Timony has requested that certain surplus personal property owned by the Village, as described herein be disposed of pursuant to State law because it is no longer necessary, useful to, or in the best interests of the Village to retain the surplus personal property; and

WHEREAS, the Village President and Board of Trustees deem it no longer necessary, useful to, or in the best interests of the Village to retain the surplus personal property described herein and made a part hereof, and desire that the Village Manager dispose of such property in any lawful manner.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION I. Declaration of Surplus Property; Approval of Sale/Disposal. The Village President and Board of Trustees find and declare that all itemized property below is surplus personal property because it is no longer necessary, useful to, or in the best interests of the Village to retain such property. The Village Manager, or his designee, is authorized to dispose of the surplus property in any lawful manner in "AS-IS, WHERE-IS" condition.

The following property the Village of Vernon Hills is found and declared to be surplus namely:

1. 2008 Toro Sand Pro 3040 Bunker Rake, Serial #08703-280000473

SECTION II. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall

affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION V. PUBLICATION. This ordinance shall be published in pamphlet form in the manner provided by law.

SECTION VI. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2024-065.






