

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-067**

AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE (1) 2024 MULTIHOG UTILITY TRACTOR AND ATTACHMENTS FROM BROWN EQUIPMENT COMPANY FOR AN AMOUNT NOT TO EXCEED \$162,975

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff has delineated funds within FY2025 Vehicle & Equipment Replacement Fund account (2102040-540025) for the purchase of one (1) Multihog Utility Tractor and Attachments; and

WHEREAS, said equipment will be purchased through Brown Equipment Company, 2501 S. Kentucky Ave, Evansville, IN 47714 who is an authorized equipment dealership that has been selected to provide motorized equipment to municipalities; and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract with Brown Equipment Company to purchase one (1) Multihog Utility Tractor and Attachments for an amount not to exceed \$162,975.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Brown Equipment Company to commit the Village to purchase one (1) Multihog Utility Tractor and Attachments for an amount not to exceed \$162,975.

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to Brown Equipment Company for an amount not to exceed \$162,975.

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as Ordinance number 2024-067.




