

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-060**

AN ORDINANCE AUTHORIZING THE VILLAGE MANAGER TO EXECUTE A CONTRACT WITH MORTON SALT, INC. TO PURCHASE AND DELIVER BULK ROCK SALT FOR AN AMOUNT NOT TO EXCEED \$116,522

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff budgeted \$116,522 for the purchase of bulk road salt in the FY2025 Snow Removal Supplies account (0102040-530095); and

WHEREAS, the Village participated in the 2024 Lake County Joint Bid for the purchase and delivery of bulk rock salt; and

WHEREAS, Morton Salt, Inc. was awarded a two-year contract for FY2025 and FY2026; and

WHEREAS, the Village will commit to purchase between 1,120 and 2,100 tons of rock salt under the FY2025 contract with Morton Salt, Inc. at a cost of \$84.90 per ton; and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract with Morton Salt, Inc. for FY2025 for an amount not to exceed \$116,522.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Morton Salt, Inc. for the purchase and delivery of bulk rock salt within FY2025 for an amount not to exceed \$116,522.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Morton Salt, Inc. for amount not to exceed \$116,522.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-060.


