

**VILLAGE OF VERNON HILLS  
ORDINANCE 2024-061**

**AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO CLARKE MOSQUITO MANAGEMENT, INC. TO PERFORM MOSQUITO ABATEMENT SERVICES FOR AN AMOUNT NOT TO EXCEED \$61,300**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Ordinance 2022-019 authorized the Village to enter into a 3-year contract from FY2023 through FY2025 with Clarke Mosquito Management, Inc. for the Village of Vernon Hills Environmental Mosquito Management Program; and

WHEREAS, Staff has budgeted \$61,300 for insect control services in FY2025 budget account (0102040-520610); and

WHEREAS, the base contract price includes four (4) Village-wide sprays, surveillance and monitoring, larval control, and some special event sprays; and

WHEREAS, expenditures over \$25,000 require Board of Trustee approval.

WHEREAS, Staff seeks approval to authorize the Finance Director to execute payments to Clarke Mosquito Management, Inc. to provide mosquito abatement services for an amount not to exceed \$61,300.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is authorized to execute payments to Clarke Mosquito Management, Inc. for Environmental Mosquito Management services for an amount not to exceed \$61,300.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2024-061.




