

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-062**

**AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO
PETROLEUM TRADERS CORP. FOR THE PURCHASE AND DELIVERY OF
GASOLINE AND DIESEL FUEL FOR AN AMOUNT NOT TO EXCEED \$300,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village purchases fuel for use in it's fleet from a fuel supplier; and

WHEREAS, Ordinance 2023-027 awarded a two-year contract to Petroleum Traders Corp. to provide unleaded and diesel fuel for FY2024 and FY2025; and

WHEREAS, Staff has delineated \$300,000 within FY2025 budget account (0102040-530140) for said fuel; and

WHEREAS, expenditures over \$25,000 require Board of Trustee approval; and

WHEREAS, Staff seeks approval to authorize the Finance Director to execute payments to Petroleum Traders Corp. for the purchase and delivery of fuel for an amount not to exceed \$300,000.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Petroleum Traders Corp. for the purchase and delivery of fuel for an amount not to exceed \$300,000.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-062.






