

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-075**

**AN ORDINANCE AUTHORIZING A PAYMENT TO MOTOROLA FOR ANNUAL
AIRTIME FEES IN AN AMOUNT NOT TO EXCEED \$27,888.00**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Vernon Hills Police Department operates on the Starcom 21 radio system that requires the purchase of airtime on a monthly subscription basis; and

WHEREAS, Motorola has been identified as the sole source provider of services that are necessary for successful police operations.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, as follows:

SECTION 1: EXECUTION OF PAYMENT, The Finance Director is hereby authorized to issue payment to Motorola for annual fees in an amount not to exceed \$27,888.00.

SECTION 2: EFFECTIVE DATE, This Ordinance shall be in full force and effect upon its passage and approval by a majority of the members of the Village Board.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-075.






