

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-083**

AN ORDINANCE AWARDING A CONTRACT TO GEWALT HAMILTON ASSOCIATES, INC. TO PROVIDE PROFESSIONAL GEOSPATIAL SERVICES FOR AN AMOUNT NOT TO EXCEED \$45,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village maintains a robust geographic information system (GIS) for all Village assets; and

WHEREAS, Gewalt Hamilton Associates, Inc. provides professional services to manage and develop GIS services; and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract with Gewalt Hamilton Associates, Inc. to provide professional geospatial services for for an amount not to exceed \$45,000.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all documents required with Gewalt Hamilton Associates, Inc. to provide professional geospatial services for an amount not to exceed \$45,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Gewalt Hamilton Associates, Inc. for an amount not to exceed \$45,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effective from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-083.






