**AN ORDINANCE AUTHORIZING AND APPROVING THE PURCHASE OF NINE IN-CAR COMPUTERS AND RELATED EQUIPMENT FOR PATROL VEHICLES FROM CDS OFFICE TECHNOLOGIES FOR AN AMOUNT NOT TO EXCEED \$34,938.00**

**Whereas**, the current in-car computers that need replacement have reached the end of their life expectancy, and the Department has a replacement plan in which the oldest computers are replaced and updated; and

**Whereas**, in addition to computer-aided dispatch, the Department utilizes electronic citation and accident reporting, field reporting, and operate an in-car video system; and

**Whereas**, the Police Department budgeted money for FY25 for emergency related equipment that is sufficient to cover the costs of this purchase; and

**Whereas**, this purchase meets the Village bidding requirements because CDS Office Technologies is the holder of the State of Illinois Master Contract and is capable of providing these computers and related equipment.

**NOW THEREFORE BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**That** the Village Manager is authorized to direct the Police Department to purchase the necessary equipment, not to exceed \$34,938.00, from CDS Office Technologies using established account 2103030-540045.




