

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-080**

AN ORDINANCE AUTHORIZING THE VILLAGE MANAGER TO EXECUTE A CONTRACT RENEWAL WITH ADVANCED TREE CARE TO PERFORM PARKWAY TREE TRIMMING SERVICES FOR AN AMOUNT NOT TO EXCEED \$60,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Ordinance 2023-092 awarded a one-year contract to Advanced Tree Care to perform Parkway Tree Trimming Services in FY2024; with the option to renew the contract for up to two additional one-year terms through FY2026; and

WHEREAS, Advanced Tree Care has agreed to renew said contract for FY2025; and

WHEREAS, Staff has budgeted \$60,000 for parkway tree trimming in FY2025 budget account (0106047-520600); and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract renewal with Advanced Tree Care to provide Parkway Tree Trimming Services throughout FY2025 for an amount not to exceed \$60,000.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to renew the current contract with Advanced Tree Care to provide Parkway Tree Trimming Services throughout FY2025 for an amount not to exceed \$60,000.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Advanced Tree Care for an amount not to exceed \$60,000.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-080.






