

**VILLAGE OF VERNON HILLS  
ORDINANCE 2024-107**

**AN ORDINANCE AMENDING CHAPTER 3, ALCOHOLIC LIQUOR CONTROL, OF THE  
VERNON HILLS CODE, SECTION 3-12, LICENSE CLASSIFICATION AND FEES,  
RELATED TO THE QUANTITY OF CLASS "A" AND CLASS "L" LICENSES**

**WHEREAS**, the Village of Vernon Hills is a municipal corporation existing under the laws of the State of Illinois, and

**WHEREAS**, the Village, as a municipal corporation, has a duty to regulate the purchase, sale and serving of alcoholic beverages to the public for the protection of the public, health, safety, morals and welfare; and

**WHEREAS**, the Village has received notice from Jameson's Charhouse, 151 W. Townline Road, that the business has closed, and therefore the quantity of Class "A" licenses in Section 3-12 must be reduced to reflect the correct number of licenses available; and

**WHEREAS**, the Village has received notice from Dramhammer Auctions, 50 Fairway Drive, that the business has closed, and therefore the quantity of Class "L" licenses in Section 3-12 must be reduced to reflect the correct number of licenses available; and

**WHEREAS**, the President and Board of Trustees hereby adopt this ordinance amending the Liquor Control Ordinance of the Village of Vernon Hills pursuant to its duty to regulate the purchase and sale of alcoholic beverages within the Village of Vernon Hills.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:**

**SECTION I.** The above listed recitals are incorporated into and made part of this Ordinance.

**SECTION II. AMENDMENT, CLASS A.** That Chapter 3 Section 3-12 of the Village of Vernon Hills Code of Ordinances, Section, 3-12(1), Class "A" License is hereby amended as follows:

*3-12(1) Class "A" License:* A class "A" liquor license shall authorize the retail sale of alcoholic liquors for consumption only on the premises specified. There shall not be issued at any one time any more than ~~thirty-five (35)~~ **thirty-four (34)** class "A" liquor licenses in the village.

**SECTION III. AMENDMENT, CLASS L.** That Chapter 3 Section 3-12 of the Village of Vernon Hills Code of Ordinances, Section, 3-12(12), Class "L" License is hereby amended as follows:

*3-12(12) Class "L" License:* A class "L" license shall authorize the online sale of alcoholic beverages not for consumption on the premises. Class "L" licenses shall be subject to the following conditions and limitations.

8. Not more than ~~one~~ **zero (0)** class "L" license licenses shall be issued at any one time in the village.

**SECTION IV. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

**SECTION V. REPEAL AND SAVINGS CLAUSE.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

**SECTION VI. EFFECTIVE DATE.** This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.


**SECTION VII. ORDINANCE NUMBER.** This ordinance shall be known as Ordinance Number 2024-107.


