

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-110**

AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND TO PURCHASE ONE (1) CHRYSLER PACIFICA AWD VAN FROM MILLER MOTOR SALES INC. FOR AN AMOUNT NOT TO EXCEED \$46,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff has delineated funds within FY2025 Vehicle & Equipment Replacement Fund account (2103030-540025) for the purchase of one (1) 2024 Chrysler Pacifica Police administrative vehicle; and

WHEREAS, said vehicle will be purchased through Miller Motor Sales, Inc., 1196 Milwaukee Ave, Burlington, WI 53105, who is an authorized Chrysler dealership that has been selected to provide motor vehicles to municipalities; and

WHEREAS, Staff seeks authorization to waive the competitive bidding process and to authorize the Village Manager to execute a contract with Miller Motor Sales, Inc. to purchase one (1) 2024 Chrysler Pacifica for an amount not to exceed \$46,000.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Miller Motor Sales, Inc. to commit the Village to purchase one (1) 2024 Chrysler Pacifica for an amount not to exceed \$46,000.

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to Miller Motor Sales, Inc. for the amount of \$46,000.

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as ORDINANCE NUMBER 2024-110.


