

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-111**

**AN ORDINANCE AWARDING THE VILLAGE WIDE FENCE REPLACEMENT
CONTRACT TO ASPEN FENCE CO. FOR \$50,500**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village maintains the buildings and grounds at several facilities throughout the Village and five (5) of the locations (Metra Station, Muni Golf Course, Police Station, 7 E. Phillip Rd., and VHAC) have fencing needing replacement; and

WHEREAS, the Village received a total of seven (7) sealed bids on August 7, 2024 for the Village Wide Fence Replacement; at which time they were publicly opened; and

WHEREAS, Aspen Fence Co. provided the lowest qualifying bid; and

WHEREAS, this Ordinance awards the Village Wide Fence Replacement Contract to Aspen Fence Co. for \$50,500.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required contract documents for the Village Wide Fence Replacement Contract to Aspen Fence Co. for \$50,500.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Aspen Fence Co. for \$50,500.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-111.


