ORDINANCE 2024-112**

**AN ORDINANCE AWARDING THE VHAC BACKSTOP NETTING REPLACEMENT  
CONTRACT TO NATIONAL SPORTS NETS, LLC FOR \$79,885**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village maintains the Vernon Hills Athletic Complex (VHAC) property and the existing backstop netting is in need of replacement on four (4) baseball/softball fields; and

**WHEREAS**, the Village received a total of three (3) sealed bids on August 7, 2024 for the VHAC Backstop Netting Replacement; at which time they were publicly opened; and

**WHEREAS**, National Sports Nets, LLC provided the lowest qualifying bid; and

**WHEREAS**, this Ordinance awards the VHAC Backstop Netting Replacement Contract to National Sports Nets, LLC for \$79,885.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required contract documents for the VHAC Backstop Netting Contract to National Sports Nets, LLC for \$79,885.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payment to National Sports Nets, LLC for \$79,885.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2024-112.


