**AN ORDINANCE AUTHORIZING THE VILLAGE MANAGER TO EXECUTE A CONTRACT CHANGE ORDER WITH THOMAS ENGINEERING GROUP FOR THE VHAC PARKING EXPANSION PROJECT FOR \$8,663.20**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Ordinance 2024-004 awarded a contract to Thomas Engineering Group to provide professional engineering services for the VHAC Parking Expansion Project; and

WHEREAS, due to utility conflicts additional design expenses were incurred on the project; and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract change order with Thomas Engineering Group the VHAC Parking Expansion Project in the amount of \$8,663.20.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required change order documents with Thomas Engineering Group for an amount not to exceed \$8,663.20.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payments to Thomas Engineering Group for an amount not to exceed \$8,663.20.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2024-119.




