

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-114**

AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO VERNON HILLS PARK DISTRICT FOR 50% OF THE COST OF FAIRGROUND PLAZA CONCRETE REPLACEMENT NOT TO EXCEED \$36,100

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village uses this space to host Vernon Hills Days and will reimburse Vernon Hills Park District for 50% of the cost to replace the Fairground Plaza concrete; and

WHEREAS, Vernon Hills Park District had contracted Schaeffges Brothers, Inc. to replace the Fairground Plaza concrete; and

WHEREAS, the Village originally budgeted \$32,500 in account 0218150-550095-25033 for this project and will be over budget by \$3,600; and

WHEREAS, expenditures over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to reimburse Vernon Hills Park District in an amount not to exceed \$36,100.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Vernon Hills Park District in an amount not to exceed \$36,100 for Fairground Plaza concrete replacement.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-114.


