

**VILLAGE OF VERNON HILLS  
ORDINANCE 2024-115**

**AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE (1) TORO  
GROUNDMASTER 4300 ROUGH MOWER FROM REINDERS FOR AN AMOUNT NOT  
TO EXCEED \$73,084.31**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Staff has delineated funds within FY2025 Golf Course Fund (Account# 1430060-540045) for the purchase of one (1) Toro Groundsmaster 4300 Rough Mower; and

**WHEREAS**, said equipment will be purchased through Reinders, 911 Tower Road, Mundelein, IL 60060 who is an authorized equipment dealership that has been selected to provide motorized equipment to municipalities; and

**WHEREAS**, Staff seeks approval to authorize the Village Manager to execute a contract with Reinders to purchase one (1) Toro Groundsmaster 4300 Rough Mower for an amount not to exceed \$73,084.31.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD  
OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Reinders to commit the Village to purchase one (1) Toro Groundsmaster 4300 Rough Mower for an amount not to exceed \$73,084.31.

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Reinders for an amount not to exceed \$73,084.31.

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as Ordinance number 2024-115.


