

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-123**

**AN ORDINANCE AUTHORIZING APPROVAL TO EXPEND FUNDS FROM THE
STATE SEIZURE FUND FOR THE PURPOSE OF TOWING EXPENDITURES NOT
TO EXCEED \$2,205**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills maintains a State Seizure Fund, from which funds are used for the purposes of funding activities and expenses associated with seizure operations; and

WHEREAS, the need for this expenditure was unforeseen and therefore not included in the current FY24-25 budget; and

WHEREAS, a payment from State Seizure Fund Account #5803039-520599 in the amount of \$2,205 is requested for the expenditures of towing fees for seized vehicles; and

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:

The Finance Director is hereby authorized to release \$2,205.00 from State Seizure Fund Account #5803039-520599.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-123.




