ORDINANCE 2024-127**

**AN ORDINANCE AUTHORIZING THE INCREASE OF ORDINANCE 2024-078  
TO A NOT TO EXCEED AMOUNT OF \$45,000.00**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Ordinance 2024-078 awarded a contract to CDS Office Technologies to provide nine in-car laptops for the Police Department at a cost not to exceed \$34,938.00; and

**WHEREAS**, due to expansion of the Police Department squad car fleet, additional expenses were incurred on the project; and

**WHEREAS**, Staff seeks approval to increase the authorize amount on Ordinance 2024-078 by an additional \$10,062.00 to \$45,000.00 and to authorize the Village Finance Director to make the additional payments to CDS Office Technologies.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required additional order documents with CDS Office Technologies for the adjusted amount not to exceed \$45,000.00.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payments to CDS Office Technologies for the adjusted amount not to exceed \$45,000.00.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2024-127.






