

**VILLAGE OF VERNON HILLS
ORDINANCE 2024-155**

**AN ORDINANCE AMENDING THE ANNUAL BUDGET OF THE VILLAGE OF VERNON HILLS,
COUNTY OF LAKE, STATE OF ILLINOIS, FOR THE FISCAL YEAR BEGINNING MAY 1, 2024
AND ENDING APRIL 30, 2025**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, by Ordinance No. 2024-058, the Village President and Board of Trustees of the Village of Vernon Hills (*“Village Board”*), Illinois adopted the Annual Budget of the Village of Vernon Hills for the fiscal year beginning May 1, 2024, and ending April 30, 2025; and

WHEREAS, subsequent to adoption of Ordinance No. 2024-058, staff had identified three Public Works vehicles that were ordered in the prior year but were not completed and fully paid for in the prior year. This resulted in final payments of \$405,000 being due in the fiscal year ending April 30, 2025 that we not included in the original budget; and

WHEREAS, funds for these purchases were available in the Vehicle and Equipment Replacement Fund (VERF) in the prior year but were not spent. No additional transfers from the General Fund are necessary to complete these purchases; and

WHEREAS, subsequent to adoption of Ordinance No. 2024-058 and in the best interest of the Village, the Village Board has determined the need to amend the fiscal year 2025 budget to accommodate additional payments of \$405,000 in the VERF to complete the purchase of the three Public Works trucks (PW002, PW016, and PW019); and

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: RECITALS: The foregoing recitals are incorporated into, and made a part of, this Ordinance as the findings of the Village Board.

SECTION 2: ADOPTION OF AMENDMENTS: The Annual Budget for the fiscal year ending April 30, 2025 shall be, and is hereby, amended to read as follows:

SECTION 5: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2024-155.


