

**VILLAGE OF VERNON HILLS  
ORDINANCE 2025-009**

**AN ORDINANCE DECLARING CERTAIN VILLAGE EQUIPMENT AS SURPLUS AND  
HAVING LITTLE VALUE AND AUTHORIZING DISPOSAL IN AN APPROPRIATE  
MANNER**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (“the Village”) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, it has been determined according to the State statutes and Village ordinances by the corporate authorities of the Village of Vernon Hills that there exists certain surplus equipment; and

**WHEREAS**, the corporate authorities desire to dispose of such surplus equipment.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1.** The Village has prepared an inventory of equipment, furniture, and miscellaneous materials that have little value and are declared to be surplus, attached hereto as **Exhibit A**.

**SECTION 2.** Said surplus equipment is to be disposed of in an appropriate manner.

**SECTION 3. SEVERABILITY.** In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications that are severable, the valid applications shall remain in effect.

**SECTION 4. REPEAL AND SAVINGS CLAUSE.** All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

**SECTION 5. EFFECTIVE DATE.** This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

**SECTION 6. ORDINANCE NUMBER.** This ordinance shall be known as Ordinance Number 2025-009.


