ORDINANCE 2025-011**

**AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND TO PURCHASE A 2025 CHEVROLET BLAZER ELECTRIC VEHICLE FOR AN AMOUNT NOT TO EXCEED \$50,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Staff has delineated funds within FY2025 Vehicle & Equipment Replacement Fund account (2104006-540025) for the purchase of an electric vehicle for the Community Development Department; and

**WHEREAS**, said vehicles will be purchased through an authorized Chevrolet dealership that has been selected to provide motor vehicles to municipalities; and

**WHEREAS**, Staff seeks authorization to waive the competitive bidding process and to authorize the Village Manager to execute a contract to purchase a 2025 Chevrolet Blazer EV for an amount not to exceed \$50,000.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract and commit the Village to the purchase of a 2025 Chevrolet Blazer EV for an amount not to exceed \$50,000.

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment for an amount not to exceed \$50,000.

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as ORDINANCE NUMBER 2025-011.


