ORDINANCE 2025-001**

**AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE (1) 2024 VERMEER BC1800XL
CHIPPER FROM VERMEER MIDWEST FOR AN AMOUNT NOT TO EXCEED \$98,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff has delineated funds within the proposed FY2025 Vehicle & Equipment Replacement Fund account (2102040-540045) for the purchase of one (1) replacement chipper; and

WHEREAS, said chipper will be purchased through Vermeer Midwest, 2801 Beverly Drive, Aurora, IL 60502 who is an authorized dealer that has been selected through a competitive bidding process to provide equipment to municipalities participating in the Sourcewell Cooperative Purchasing Contract at the rate specified in the bid (contract); and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract with Vermeer Midwest to purchase one (1) 2024 Vermeer BC1800XL Chipper for an amount not to exceed \$98,000.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute a contract with Vermeer Midwest to commit the Village to purchase one (1) 2024 Vermeer BC1800XL Chipper for an amount not to exceed \$98,000.

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to Vermeer Midwest for an amount not to exceed \$98,000.

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law.

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as Ordinance Number 2025-001.
