

**VILLAGE OF VERNON HILLS
ORDINANCE 2025-002**

AN ORDINANCE AUTHORIZING APPROVAL TO WAIVE THE COMPETITIVE BIDDING PROCESS AND TO PURCHASE SUPPLIES AND SERVICES FROM CORNERSTONE DETENTION, AND IMPERIAL SURVEILLANCE IN SUPPORT OF POLICE DEPARTMENT OPERATIONS POST 911 DISPATCH CONSOLIDATION IN A COMBINED AMOUNT NOT TO EXCEED \$49,710

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois ("*the Village*") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, Staff has delineated funds within FY2025 Capital Fund account (0218150-550076-25022) for the purchase of supplies and services for the cellblock supervision and operations; and

WHEREAS, said supplies and services will be purchased from Cornerstone Detention, who is the sole provider of the cell block operations equipment, and Imperial Surveillance, who is authorized to service the Department's card access system; and

WHEREAS, Staff seeks authorization to waive the competitive bidding process and to authorize the Village Manager to execute a contract with Cornerstone Detention in an amount not to exceed \$10,800 and execute a contract with Imperial Surveillance in an amount not to exceed \$38,910.

NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute contracts with Cornerstone Detention and Imperial Surveillance to commit the Village to purchase supplies and services a combined amount not to exceed \$49,710.00.

SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT: The Finance Director is authorized to process purchase orders and make payment to Cornerstone Detention for an amount not to exceed \$10,800 and payment to Imperial Surveillance in an amount not to exceed \$38,910.

SECTION 3: EFFECTIVE DATE: This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 4: ORDINANCE NUMBER: This ordinance shall be known as ORDINANCE NUMBER 2025-002.
