ORDINANCE 2025-006**

**AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO TIGRIS TO PERFORM AQUATIC WEED AND ALGAE CONTROL SERVICES FOR AN AMOUNT NOT TO EXCEED \$39,455**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, the Village has budgeted funds within FY2026 budget account (0106047-520600) for Algae and Weed Control Services to maintain the Village’s pond and lake locations; and

**WHEREAS**, White Deer Run contributes \$4,800 annually towards treatment costs for ponds of concern adjacent to their property as well; and

**WHEREAS**, Tigris was awarded a multi-year contract from 2024 through 2026 (Ordinance 2024-038) for Aquatic Weed & Algae Control Services with a base price of \$39,455 per year; and

**WHEREAS**, Staff seeks approval to authorize the Finance Director to execute payments in an amount not to exceed \$39,455 to Tigris for the 2025 Aquatic Weed & Algae Control Services contract;

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to execute payments to Tigris for an amount not to exceed \$39,455 within the 2026 Fiscal Year for Aquatic Weed & Algae Control Services.

**SECTION 2: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 3: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2025-006.


