

**VILLAGE OF VERNON HILLS
ORDINANCE 2025-007**

AN ORDINANCE AUTHORIZING EXPENDITURES OVER \$25,000 TO BRIGHTVIEW LANDSCAPES TO PERFORM GENERAL MOWING OF VILLAGE PROPERTY FOR AN AMOUNT NOT TO EXCEED \$99,152

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village is responsible for maintaining Village-owned properties and various Village rights of ways (ROW's); including lawn care and maintenance; and

WHEREAS, to do so efficiently and effectively, the Village contracts general mowing services for multiple locations throughout the Village; and

WHEREAS, the Village has budgeted funds within the FY2026 budget account (0106047-520600) for contractual mowing and landscape services, and

WHEREAS, Brightview Landscapes was awarded a multi-year contract from 2024 through 2026 (Ordinance 2024-037) for General Mowing of Village Property with a base price of \$89,152 per year; and

WHEREAS, Staff is including a contingency for additional expenses as needed beyond the base contract amount and/or extreme weather conditions; and

WHEREAS, Staff seeks approval to authorize the Finance Director to execute payments to Brightview Landscapes in an amount not to exceed \$99,152 for the 2025 General Mowing of Village Property contract; and

WHEREAS, expenditures over \$25,000 require Village Board approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to execute payments to Brightview Landscapes for an amount not to exceed \$99,152 within the 2026 Fiscal Year for General Mowing of Village property.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2025-007.
