

**VILLAGE OF VERNON HILLS
ORDINANCE 2025-039**

**AN ORDINANCE AMENDING CHAPTER 3, ALCOHOLIC LIQUOR CONTROL, OF THE
VERNON HILLS CODE, SECTION 3-38, LICENSE QUANTITIES BY CLASS**

WHEREAS, the Village of Vernon Hills is a municipal corporation existing under the laws of the State of Illinois, and

WHEREAS, the Village, as a municipal corporation, has a duty to regulate the purchase, sale and serving of alcoholic beverages to the public for the protection of the public, health, safety, morals and welfare; and

WHEREAS, the Liquor Control Commission, at its meeting on April 15, 2025, approved a Class “A” liquor license for Yard House USA Inc., dba Yard House #8405, 950 N. Milwaukee Avenue; and

WHEREAS, the Liquor Control Commission, at its meeting on April 15, 2025, approved a Class “Q” Liquor License for Aged in Oak LLC, dba Aged in Oak, 935 Lakeview Parkway Suite 111, subject to Special Use Permit approval and an amendment to Section 3-12 establishing the Class Q License, both scheduled for consideration by the Board on April 15, 2025; and

WHEREAS, the license class table in Section 3-38 must be amended, as illustrated in the Ordinance, to reflect the addition of the Class Q license, and to increase the quantity of Q licenses available for issuance in the Village; and

WHEREAS, due to the closure of Slyce Pizza the license class table in Section 3-38 does not need to be amended to increase the quantity of Class A licenses available for issuance in the Village to make a license available for Yard House; and

WHEREAS, the President and Board of Trustees hereby adopt this ordinance amending the Liquor Control Ordinance of the Village of Vernon Hills pursuant to its duty to regulate the purchase and sale of alcoholic beverages within the Village of Vernon Hills.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, COUNTY OF LAKE AND STATE OF ILLINOIS:

SECTION I. The above listed recitals are incorporated into and made part of this Ordinance.

SECTION II. AMENDMENT INCREASING LICENSE QUANTITIES. That Chapter 3, Alcoholic Liquor Control, of the Village of Vernon Hills Code of Ordinances, Section 3-38, is hereby amended to read as follows:

Sec. 3-38. License Quantities by Class

The quantity of licenses available for issuance at any given time within the Village of Vernon Hills shall be as follows:

Class	Description	Quantity Available
A	On premises consumption	33
B	Package	11
C	Club, on premises	0
D	Beer/wine, package	9
E	Beer/wine, on premises consumption	6
F	Catering	1
G	Special Event: Non-profit / government	N/A
H	Banquet hall	2
I	Hotel beer/wine, complimentary	1
J	Grocery; packaged w/ accessory bar	2
K	Day spa beer/wine	0
L	Online	0
M	Movie theater in mall	1
N	Convenience Store (limited spirits)	1
O	Barbershop w/ beer	0
P	On-premises service (supplement to B license)	1
Q	Tasting Room	1

SECTION III. SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION IV. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION V. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.


SECTION VI. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2025-039.


