

**VILLAGE OF VERNON HILLS
ORDINANCE 2025-043**

AN ORDINANCE AWARDING THE 2025 JOINT BID ROAD REHABILITATION TO BROTHERS ASPHALT PAVING, LLC. FOR AN AMOUNT NOT TO EXCEED \$5,467,506.15

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the President and Board of Trustees approved a budget of \$1,400,000 within budget account (0218151-550055) to address various roadway improvements; and

WHEREAS, the Village previously approved an Intergovernmental Agreement (“IGA”) for the purpose of soliciting a joint bid for the 2025 Road Rehabilitation Program with the Villages of Mundelein and Libertyville; and

WHEREAS, competitive contractor bids were opened on March 25, 2025 and received four (4) bids; and

WHEREAS, Brothers Asphalt Paving, LLC was determined to be the lowest responsive competitive bidder in the amount of \$5,467,506.15; and

WHEREAS, in accordance with the terms of the IGA, the Village shall only be responsible for the share of the contract that is directly attributable to costs associated with its roadways (\$1,400,000); and

WHEREAS, the Illinois Department of Transportation will require that the Village award the contract to the low bidder for the overall total amount of \$5,467,506.15 since the Village is the Lead Agency for the Program and because some of the parties are using Motor Fuel Tax funds.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to award the contract to Brothers Asphalt Paving, LLC for the 2025 Road Rehabilitation Program for an amount not to exceed \$5,467,506.15.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Brothers Asphalt Paving, LLC for an amount not to exceed \$1,400,000 within the 2026 Fiscal year.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2025-043.


