**AN ORDINANCE ADJUSTING THE CURRENT SENIOR STAFF SALARIES
FOR THE VILLAGE OF VERNON HILLS**

WHEREAS, the Village of Vernon Hills Compensation Plan lists the corresponding salary ranges that are authorized for Senior Staff; and

WHEREAS, the Compensation Plan is annually reviewed to assess the compensation for Village Senior Staff; and

WHEREAS, the Village Board desires to make adjustments to individual Senior Staff salaries for Fiscal Year 2026, beginning May 1, 2025.


