**AN ORDINANCE AUTHORIZING APPROVAL OF EXPENDITURES TO MILES CHEVROLET FOR THE PURCHASE OF TWO (2) 2025 CHEVROLET TAHOE PPV POLICE INTERCEPTORS IN AN AMOUNT NOT TO EXCEED \$116,144.00**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*"the Village"*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, funds are delineated within FY2026 budget account (2103030-540025) for the purchase of two (2) 2025 Chevrolet Tahoe PPV Police vehicles; and

**WHEREAS**, Miles Chevrolet, 150 W. Pershing Rd. Decatur, IL 62526 is an authorized Chevrolet dealership that provides municipal pricing for Chevrolet vehicles; and

**WHEREAS**, Staff seeks to authorize the Village Manager to execute a contract with Miles Chevrolet to purchase two (2) 2025 Chevrolet Tahoe PPV Police vehicles for an amount not to exceed \$116,144.

**NOW THEREFORE, BE IT ORDAINED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute a contract with Miles Chevrolet to purchase two (2) 2025 Chevrolet Tahoe PPV Police vehicles for an amount not to exceed \$116,144.; and

**SECTION 2: AUTHORIZATION AND RELEASE OF PAYMENT:** The Finance Director is authorized to process a purchase order and make payment to Miles Chevrolet for an amount not to exceed \$116,144.; and

**SECTION 3: EFFECTIVE DATE:** This ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

**SECTION 4: ORDINANCE NUMBER:** This ordinance shall be known as ORDINANCE NUMBER 2025-064.


