ORDINANCE 2025-069**

**AN ORDINANCE AUTHORIZING APPROVAL TO AUTHORIZE THE VILLAGE MANAGER TO EXECUTE A CONTRACT RENEWAL WITH CORRECTIVE ASPHALT MATERIALS, LLC (CAM) TO PROVIDE PAVEMENT REJUVENATION SERVICES FOR AN AMOUNT NOT TO EXCEED \$70,000**

**WHEREAS**, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

**WHEREAS**, Staff has delineated \$70,000 within FY2026 budget account (0218151-550065) for contractual Reclamite preservation sealing of Village streets; and

**WHEREAS**, the Village participated in the 2024 Municipal Partnering Initiative (MPI) Joint Bid for Pavement Rejuvenation Services; and

**WHEREAS**, Corrective Asphalt Materials, LLC (CAM) was awarded a one-year contract to provide Pavement Rejuvenation Services through the MPI in FY2025; with the option to renew said contract for up to two additional one-year terms through FY2027; and

**WHEREAS**, Staff seeks approval to authorize the Village Manager to execute a contract renewal with Corrective Asphalt Materials, LLC (CAM) to provide Pavement Rejuvenation Services in FY2026 for an amount not to exceed \$70,000.

**NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1: EXECUTION OF AGREEMENT:** The Village Manager is hereby authorized to execute all required documents with Corrective Asphalt Materials, LLC to provide Pavement Rejuvenation Services in FY2026 for an amount not to exceed \$70,000.

**SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT:** The Finance Director is hereby authorized to make payments to Corrective Asphalt Materials, LLC in an amount not to exceed \$70,000.

**SECTION 3: EFFECTIVE DATE:** This Ordinance shall be in full force and effect from its passage and approval.

**SECTION 4: ORDINANCE NUMBER:** This Ordinance shall be known as Ordinance Number 2025-069.




