

**VILLAGE OF VERNON HILLS
ORDINANCE 2025-077**

**AN ORDINANCE AUTHORIZING A PAYMENT TO FLOCK SAFETY FOR THE
PURPOSE OF SOFTWARE RENEWAL NOT TO EXCEED \$51,000**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Police Department has received awarded grant monies including \$51,000 from the Illinois Attorney General’s Office for an Organized Retail Crime Grant (25-0180ORC). The Police Department intends to utilize the Organized Retail Crime Grant monies towards the software renewal of seventeen existing automated license plate readers (ALPRs) and additional camera and software updates.

WHEREAS, this Grant was anticipated and therefore included in the current FY25-26 budget; and

WHEREAS, staff recommends the software renewal of seventeen existing automated license plate readers (ALPRs), originally installed utilizing grant monies, from Flock Safety for an amount not to exceed \$51,000; and

WHEREAS, expenditures over \$25,000 require Board of Trustee approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all required documents to renew the service agreement for ALPRs from Flock Safety at a price not to exceed \$51,000 from Account #0103032-520216; and

SECTION 2: EXECUTION OF PAYMENT: The Finance Director is authorized to process a purchase order and make payment to Flock Safety in an amount not to exceed \$51,000; and

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage, approval and publication as provided by law; and

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2025-077.




