ORDINANCE 2025-104**

AN ORDINANCE AUTHORIZING APPROVAL OF A PAYMENT TO ADVANCED BUSINESS NETWORKS FOR INFORMATION TECHNOLOGY SUPPORT FOR FISCAL YEAR 2026 IN AN AMOUNT NOT TO EXCEED \$50,000

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village uses Advanced Business Networks for its information technology support; and

WHEREAS, the Village’s FY2026 budget anticipated a cost of \$124,800 for these services; and

WHEREAS, staff recommends purchasing hours in blocks necessary to obtain the maximum discount and as needed throughout the year. Advanced Business Networks offers blocks of at least three hundred hours of Information Technology support at a the maximum discount of 20%; and

WHEREAS, three hundred hours of support time at the maximum discounted rate of \$156 per hour costs \$46,800 for Village-wide information technology support; and

WHEREAS, expenditures over \$25,000 require Board of Trustees approval.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payment to Advanced Business Networks in an amount not to exceed \$50,000 for information technology support for Fiscal Year 2026 and authorized to immediately release payment to Advanced Business Networks for information technology support prior to appearing on the invoice approval list.

SECTION 2: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 3: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2025-104.
