

**VILLAGE OF VERNON HILLS
ORDINANCE 2025-124**

**AN ORDINANCE AUTHORIZING AN AGREEMENT WITH ILLINOIS COUNTIES RISK
MANAGEMENT TRUST TO PROVIDE INSURANCE COVERAGE FOR THE POLICY YEAR
OF DECEMBER 1, 2025 - DECEMBER 1, 2026 FOR AN AMOUNT NOT TO EXCEED \$913,336**

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the Village of Vernon Hills (*“Village”*) must maintain liability, commercial property, and worker’s compensation insurance (*“insurance coverage”*); and

WHEREAS, the Village Board has determined that Alliant Insurance Services (*“Alliant”*) is well suited to act as the Village's Broker on behalf of the Village of Vernon Hills’ liability, commercial property, and worker’s compensation insurance plans; and

WHEREAS, Alliant has solicited quotes from the market for insurance coverage and recommends that the Village obtain insurance coverage from Illinois Counties Risk Management Trust (*“ICRMT”*), and

WHEREAS, premiums for this insurance coverage total \$913,336, plus deductibles on claims submitted; and

WHEREAS, the Vernon Hills Village Board (*“Village Board”*) has determined that it is in the best interest of the Village to bind insurance coverage with ICRMT for the December 1, 2025 - December 1, 2026 coverage year.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager shall be, and is hereby, authorized to execute documents required to bind insurance coverage with the Illinois Counties Risk Management Trust, as approved by the Village’s Corporation Counsel.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to commit the Village to make premium payments to Illinois Counties Risk Management Trust in the amount of \$913,336, or proportionately greater, to issue payments for insurance deductibles, and authorize the release of these payments prior to appearing on the Board Invoice Approval List.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effect from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2025-124.




