AN ORDINANCE AWARDED A CONTRACT TO KLUBER INC. TO PROVIDE PROFESSIONAL ARCHITECTURAL SERVICES FOR THE VILLAGE HALL SIDING REPLACEMENT PROJECT FOR AN AMOUNT NOT TO EXCEED \$33,975

WHEREAS, the Village of Vernon Hills, County of Lake, State of Illinois (*“the Village”*) is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code; and

WHEREAS, the President and Board of Trustees desire to maintain the Village’s facilities; and

WHEREAS, Staff received a proposal from Kluber Inc. for providing architectural services to design the replacement of the siding on the exterior of the Village Hall.; and

WHEREAS, Staff seeks approval to authorize the Village Manager to execute a contract with Kluber Inc. to provide professional architectural services for the Village Hall Siding Replacement Project for an amount not to exceed \$33,975.

NOW THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: EXECUTION OF AGREEMENT: The Village Manager is hereby authorized to execute all documents required with Kluber Inc. to provide professional architectural services for the Village Hall Siding Replacement Project for an amount not to exceed \$33,975.

SECTION 2: AUTHORIZATION & RELEASE OF PAYMENT: The Finance Director is hereby authorized to make payments to Kluber Inc. for an amount not to exceed \$33,975.

SECTION 3: EFFECTIVE DATE: This Ordinance shall be in full force and effective from its passage and approval.

SECTION 4: ORDINANCE NUMBER: This Ordinance shall be known as Ordinance Number 2025-128.




