

**VILLAGE OF VERNON HILLS
ORDINANCE 2025-133**

**AN ORDINANCE ABATING THE TAX HERETO LEVIED FOR THE TAX YEAR 2025 TO PAY
THE PRINCIPAL AND INTEREST ON \$7,850,000 GENERAL OBLIGATION BONDS, SERIES
2012A, OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS**

WHEREAS, the President and Board of Trustees (the "*Corporate Authorities*") of the Village of Vernon Hills, Lake County, Illinois (the "*Village*"), by an ordinance adopted on the 7th day of February, 2012 (the "*Ordinance*"), did provide for the issue of \$7,850,000 General Obligation Bonds, Series 2012A (the "*Bonds*"), and the levy of a direct annual tax to pay the principal of and interest on the Bonds; and

WHEREAS, funds from a lawfully available source not derived from any borrowing (the "*Lawfully Available Funds*") are available for the purpose of paying principal and interest on the bonds up to and including December 30, 2026; and

WHEREAS, the Lawfully Available Funds are available in an amount sufficient to pay debt service on all the Bonds up to and including December 30, 2026; and

WHEREAS, it is necessary and in the best interests of the Village that the tax heretofore levied for the tax year 2025 to pay the principal of and interest on the Bonds be abated;

NOW THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Village of Vernon Hills, Lake County, Illinois, as follows:

SECTION I: ABATEMENT OF TAX. The tax heretofore levied for the tax year 2025 in the Ordinance is hereby abated in its entirety.

SECTION II: FILING OF ORDINANCE. Forthwith upon the adoption of this ordinance, the Secretary of the Corporate Authorities shall file a certified copy hereof with the County Clerk of The County of Lake, Illinois, and it shall be the duty of said County Clerk to abate said tax levied for the tax year 2025 in accordance with the provisions hereof.

SECTION III: EFFECTIVE DATE. This ordinance shall be in full force and effect forthwith upon its passage by the Corporate Authorities and signing and approval by the President.

SECTION IV: SEVERABILITY. In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in any one or more of its several applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION V: REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION VI: PUBLICATION. This ordinance shall be published in pamphlet form in the manner provided by law.

SECTION VII. EFFECTIVE DATE: This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION VIII: ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2025-133.

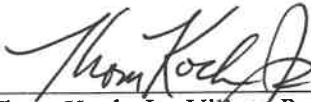

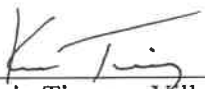

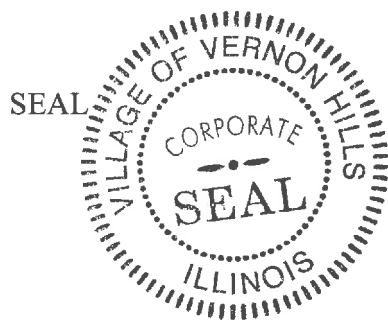
