

RESOLUTION 2009-056

**A RESOLUTION AMENDING RESOLUTIONS 2008-162 AND 2008-163
AUTHORIZING THE VILLAGE BOARD TO INCREASE PURCHASE ORDERS TO
JAMES MARTIN ASSOCIATES, INC., BEST LAWNS, INC., ASPEN LANDSCAPING,
THE ARROW SHOP, AND ACRES GROUP, TGF ENTERPRISES, INC. FOR SALTING
OF STREETS, CUL-DE-SAC SNOW REMOVAL, AND PARKING LOT SNOW
REMOVAL FROM \$159,076 TO \$179,000.**

WHEREAS, \$165,000 is budgeted in FY 08-09 Street Contractual Services (0102040 520630) for said area salting, snow removal, and sidewalk snow removal.

WHEREAS, James Martin Associates, Inc., The Arrow Shop, Acres Group, Best Lawns, Aspen Landscaping, TGF Enterprises, Inc. provided snow and ice control services in 2008/09; and

WHEREAS, December 2008 and January 2009 snowfall amounts were above 50 inches and resulted in additional contract costs; and

WHEREAS, \$10,000 is available in Contingencies, account 010909-58003 for said extreme weather events; and

WHEREAS, contracts established 45 inches of snowfall for the season and additional funds are needed for February and March 2009.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

That, the Finance Director is authorized to transfer \$10,000 from Contingencies, account 010909-58003 to Street Contractual Services (0102040 520630); and

The Village Board authorizes increase in the Purchase Orders to James Martin Associates, Inc., The Arrow Shop, Acres Group, Best Lawns, TGF Enterprises, Inc., and Aspen Landscaping and to make payments in accordance with the proposals and contracts; and

That the Finance Department is authorized to pay James Martin and Associates an amount not to exceed \$135,000 for snow plowing services; and

That the Finance Department is authorized to pay TGF Enterprises, Inc. an amount not to exceed \$25,000 for snow plowing services; and

That, the Finance Department is authorized to make payments to the above listed vendors in a total amount not to exceed \$179,000.

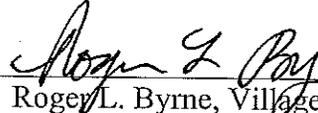

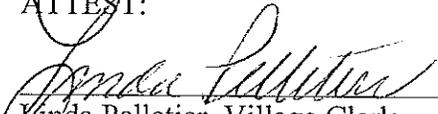
