

RESOLUTION 2009-066

A RESOLUTION AWARDING THE FUEL CONTRACT AND APPROVING A PURCHASE ORDER TO WARREN OIL CO., INC. FOR THE PURCHASE OF GASOLINE AND DIESEL FUEL IN THE AMOUNT OF \$177,750 FOR THE 2009/2010 BUDGET YEAR

WHEREAS, the Village of Vernon Hills Public Works Department budgeted \$177,750.00 for the purchase of gasoline and diesel fuel in account: 0102040-530140 for the 2009/2010 budget year; and

WHEREAS, at this time Community School District #128, Cook Memorial Library, Countryside Fire Protection District, and the MEG Unit all purchase fuel from the Village; and

WHEREAS, bids were opened on March 31, 2009 and received from Warren Oil Co., Inc. (Summit, IL), Avalon Petroleum (Tinley Park, IL), Petroleum Traders Corporation (Ft. Wayne, IN), Conserv/FS (Woodstock, IL), Osco Inc. (Lemont, IL) and Bell Fuels (Cicero, IL.); and

WHEREAS, the low bidder was Warren Oil Co., Inc.; and

WHEREAS, providing Warren Oil Co., Inc. meets the Village's insurance requirements, they will be determined to be the best-qualified bidder to provide gasoline and diesel fuel.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS:

That the Village Board accepts the Warren Oil Co., Inc. bid and;

THAT the contract be awarded to Warren Oil Co., Inc. for the purchase of gasoline and diesel fuel for the two year period beginning May 1, 2009 and ending April 30, 2011; and

THAT a Purchase order will be issued for FY 2009-2010 in the amount to not exceed \$177,750.00.

THAT the Finance Director is authorized to increase the Purchase Order for additional fuel purchases from all monies reimbursed by outside users; and

THAT the Village Manager is authorized to execute the contract and to commit the Village to make payments to Warren Oil Co., Inc.




