AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE VILLAGE OF VERNON HILLS, CHAPTER 22 – TRAFFIC AND MOTOR VEHICLES

WHEREAS, in order to promote the public health, safety and general welfare of the residents of Vernon Hills, the Board of Trustees of the Village of Vernon Hills, a Home-Rule community, is authorized to prescribe rules and regulations to regulate traffic and motor vehicles within the Village; and

WHEREAS, the Village is a highly desirable location for activities and events which attract large numbers of people and vehicles to public and private locations within the Village; and

WHEREAS, the Village periodically finds that, due to the numbers of vehicles coming to a specific area, it becomes necessary to temporarily regulate parking within the public rights of way adjacent to these events; and

WHEREAS, temporarily regulating parking adjacent near the event sites insures that traffic circulation patterns and access for emergency vehicles are maintained at all times; and

WHEREAS, the Board of Trustees, due to concerns with maintaining traffic circulation patterns and access for emergency vehicles adjacent to public and private event sites, has proposed to amend Chapter 22, Section 22-268 of the Vernon Hills Code of Ordinances to allow the posting of temporary No Parking signs if and when deemed necessary for the public health, safety and welfare as a result of an event or series of events that are relatively short in duration.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF VERNON HILLS, LAKE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That Chapter 22, Section 22-268 of the Village of Vernon Hills Code of Ordinances is hereby amended by adding the wording as underlined below and is approved to read as follows:

Section 22-268 - Posting of Signs:

The Chief of Police or any other person authorized by the president and board of trustees shall cause signs to be posted in all areas where parking is limited or prohibited,

indicating such limitations or prohibitions. This includes the authority to post temporary no parking signs if and when deemed necessary for the public health, safety and welfare as a result of an event or series of events that are relatively short in duration.

SECTION II. SEVERABILITY. In the event that any section, clause, provision or part of this Ordinance shall be found and finally determined to be invalid by a Court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this Ordinance is found to be invalid in any one or more of its applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION III. REPEAL AND SAVINGS CLAUSE. All ordinances or parts of ordinances in conflict herewith are hereby repealed; provided, however, that nothing herein contained shall affect any rights, actions or causes of action which shall have accrued to the Village of Vernon Hills prior to the effective date of this ordinance.

SECTION IV. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

SECTION V. ORDINANCE NUMBER. This ordinance shall be known as Ordinance Number 2011-038.
